Services to be Supplied:

To support PALNI Fulfillment efforts (following the Strategic Framework), the Independent Contractor will:

- Provide approved support for PALNI Fulfillment efforts for individual PALNI-supported institutions (ILL)
 - Manage ILL activities including processing requests, system configuration settings, follow standard practices, provide reporting etc. for approved requesting institutions
 - o Develop and document standardized processes and practices for interlibrary loan
 - Provide project updates and reports as requested
- Provide approved support and consultation for PALNI group borrowing efforts across the PALNI consortial borrowing system (PALShare)
 - Verify standard configuration of group circulation within the shared library system
 - Analyze group circulation issues and suggest solutions and/or communicate to support and/or product development staff
 - Produce reports of group circulation activity
 - o Produce documentation on group circulation workflows, best practices, and settings
 - Identify training resources to reach standard levels of service (all PALNI-supported organizations can quickly and easily share resources via PALNI systems)
- To perform the functions above the Fulfillment consultant will:
 - Conduct necessary consultative meetings with approved supported institutions to implement, maintain, assess, and enhance services
 - Provide input to the fulfillment task force and fulfillment advisory group regarding issues related to systems and workflows of supported institutions and services above
- Any additional services may be negotiated between PALNI and the Independent Contractor

A successful contract bid will have these Skills & Qualifications and be able to demonstrate how you will meet the requested services:

- Demonstrated knowledge of interlibrary loan practices in academic libraries
- Demonstrated ability to work with different interlibrary loan systems, specifically Worldshare ILL, ILLiad, and Tipasa
- Ability to work independently and across multiple interlibrary loan instances
- Awareness of consortial resource sharing practices and technologies

Work Arrangement: The Independent Contractor operates remotely, providing their own computer equipment, software, and internet access. The Independent Contractor is expected to meet with the PALNI Associate Director on a regular basis, but not less than monthly, to provide requested project updates. The Independent Contractor is not an employee of PALNI.

Compensation and Contract Term: Independent Contractor shall invoice PALNI on a monthly basis for Services performed. Fees are paid monthly, with the Independent Contractor providing services for agreed-upon hours during the term of the Independent Contractor Agreement. The term of this contract will be two years. The total budget for this project is \$15,500.

Proposals should include a comprehensive budget, specifying the total bid amount as well as a breakdown of costs by deliverable, hourly rate, or milestone.
